

Parasitoids released to combat Emerald Ash Borer in Main

MAINE DEPARTMENT OF AGRICULTURE, CONSERVATION AND FORESTRY

To battle the emerald ash borer (EAB) infestation, Maine Forest Service is releasing parasitoids in Aroostook County. Parasitoids are tiny non-stinging wasps that feed in or on EAB by attacking immature (larvae) EAB under the bark of ash trees and parasitizing eggs on the surface of the bark. The parasitoid species being released in Aroostook County are *Oobius agrili, Tetrastichus planipennisi* and *Spathius galinae*. READ ON

Operators champion landfill gas as a source of renewable energy and revenue. But as communities seek to divert more organics and climate anxiety intensifies, the practice has been decried as greenwashing. The full story of landfill gas (LFG) is complicated. Capturing LFG creates beneficial use opportunities and earns operators revenue, in addition to reducing the global warming potential of the gas that is successfully captured.
