Berkshire Conservation District Announces No-Till Farmland Initiative

Berkshire Conservation District is pleased to announce the receipt of grant funding from the Commonwealth of Massachusetts Executive Office of Energy and Environmental Affairs (EEA), Division of Conservation Services, Conservation District Innovation Grants Program, and the Massachusetts Department of Agricultural Resources (MDAR) for a project to increase the use of notill seeding methods by farmers throughout the county. This approach to planting helps reduce soil erosion, conserve water, improve soil health and increase carbon sequestration while educating local and regional farmers as well as the public about the benefits of these farming methods. Work on the Mill Street Dam is now scheduled to start next week, with about \$1 million more tacked onto the price tag. This year, the project cost was estimated at \$1.9 million. But the bids came in higher than expected, said Jim McGrath, the city's parks and natural resource program manager. The lowest bid went to SumCo Eco Contracting, whose bid was \$2,582,950. READ ON

Of all the solutions to climate change, ones that involve trees make people the happiest. Earlier this year, when a Swiss study announced that planting 1.2 trillion trees might cancel out a decade's worth of carbon emissions, people swooned (at least on Twitter). And last month, when Ethiopian officials announced that twenty-three million of their citizens had planted three hundred and fifty million trees in a single day, the swooning intensified. Eggshells **CHARLEY EISEMAN | BUGTRACKS**

On Monday I spotted these little eggshells on a tall blue lettuce (Lactuca biennis) plant growing under the black cherry (Prunus serotina) tree in my yard: [CLICK LINK TO SEE PHOTOS] There aren't many insect eggs I would identify to species with confidence, but these brown-rimmed hockey pucks were without a doubt deposited by a polyphemus moth (Antheraea polyphemus). This makes four giant silk moth (Saturniidae) species I have now found in my yard. READ ON
