
Spotlight: Study finds blue hydrogen worse for climate than burning coal or gas



Emissions associated with producing blue hydrogen from gas were actually <u>greater than</u> emissions from burning gas or coal directly. This was because of the significant extra energy required for processes to produce hydrogen and power carbon capture and storage. The hydrogen industry is a significant source of climate pollution globally, responsible for around 830 million tons of carbon dioxide every year.... That's because <u>nearly all hydrogen produced and used today comes from fossil fuels</u>, and is classed as either 'grey' (from gas) or 'brown' (from coal). 'Blue' hydrogen involves producing hydrogen from coal or gas with the addition of carbon capture and storage. 'Green' hydrogen is produced using a process called electrolysis powered by renewable energy. **Read More**

Surface Water Vulnerable to Widespread Pollution From Fracking, a New Study **Finds**

Years of research has shown how the fracking boom has contaminated groundwater in some areas. But a study published on Thursday in the journal *Science* suggests there is also a previously undocumented risk to surface water in streams, rivers and lakes. After analyzing 11 years of data, including surface water measurements in



408 watersheds and information about more than 40,000 fracking wells, the researchers found a very small but consistent increase in three salt compounds—barium, chloride and strontium—in watersheds with new wells that were fracked. Read More

A GPS tracking unit is aboard to map out designated routes for removal of <u>invasive Eurasian milfoil</u> from 9 acres of the 398-acre state-owned "Great Pond." Roxanne McCaffrey explained that the navigation device enables the harvester to avoid lakeshore areas protected by <u>MassWildlife's Natural Heritage and Endangered Species</u> <u>Program</u>.
